## **Terms and Conditions of Credit Agreement**

This is an "Application" and "Agreement" for credit and shall apply to any and all credit extended by YIT. The credit applicant understands and agrees to the following terms and conditions of sale:

- 1. Terms of sale are **NET 30 days**. Agents or representatives of YIT are not authorized to change or adjust credit terms without written authorization of the Credit Manager.
- Special terms granted to your company may be revoked if the account is not maintained in good standing. Invoices not paid after
  the due date means your account is NOT in good standing. Interest is charged on past due accounts at the rate of 18% per annum (subject
  to change) on unpaid invoices after their due date.
- 3. All claims against invoices must be made within ten days after receipt of goods or services to authorized personnel.
- 4. Goods may NOT be returned without prior authorization of YIT.
- 5. Goods/Merchandise when authorized for return will be subject to a minimum 20% restocking charges.
- 6. NSF cheques will be subject to a \$35.00 charge
- 7. Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice.
- 8. Applicant agrees to bear all costs incurred in collecting any unpaid amounts including but not limited to, legal fees and court costs on solicitor/client basis.
- 9. The information given in this Application and Agreement is warranted to be true, complete and correct and given for the purpose of obtaining credit.
- 10. The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with whom the applicant has or proposes to have financial relations.
- 11. This Agreement shall be governed by the laws of the Province of Ontario and the laws of Canada applicable in Ontario.
